- 6. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Baiteshwor rural municipality, Pandudanda, Dolakha 12:00PM on 26th August 2022. Bids received after this deadline will be rejected.
- 7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 on 26th August 2022 at the office of Baiteshwor rural municipality, Pandudanda, Dolakha. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Nrs.1,85,000(One lakh eighty five thousands), which shall be valid for minimum 30 days beyond the bid validity period [i.e. 120 days].
- 8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
